

# BRC CERTIFICATE FOR THE TWELFTH TIME FOR PRO-FLEX S.A.



**BRC – British Retail Consortium – published the first version of BRC Standard in Great Britain in 1998.** It was a document that clearly outlined requirements for food manufacturers delivering food of their own brand to British hypermarket chains. Following that, BRC and British Institute of Packaging (IOP) developed a global standard BRC IOP for producers of packaging and packaging materials. The standard was introduced to help protect a consumer, giving a common basis for companies in preparation to supply packaging materials for food. At present, all producers and distributors of packaging materials and articles are bound by provisions contained in Commission Regulation (EC) No 2023/2006 of 22 December 2006 on good manufacturing practice for materials and articles intended to come into contact with food.
